## URBAN AREA OF WILLARD BEACH.—CURFEW.

Under the powers vested in me by sub-section (1) of section *thirty-one* of the Natives (Urban Areas) Consolidation Act, 1945 (Act No. 25 of 1945), I hereby declare that with effect from the date of promulgation hereof, no Native, male or female, not being exempted under sub-section (4) of the said section, shall between the hours of 10 p.m. and 4 a.m. be in any public place within the area controlled by the urban local authority of Willard Beach, unless such Native be in possession of a written permit signed by his employer or by a person authorised by such employer to issue such permit to such Native or by some person authorised by the said urban local authority or the Minister to issue such permits or by any member of the South African Police.

## ALTERATION OF DESIGNS ON UNION COINS.

- (b) that the dimensions of the said coins shall be identical with those of the corresponding coins [according to the table in paragraph (a) of sub-section (2) of section *one* of the Decimal Coinage Act, 1959 (Act No. 61 of 1959)], mentioned in the Schedule to the Coinage Act, 1922 (Act No. 31 of 1922), that are in circulation on the said date.

#### WYSIGING VAN GEVANGENISREGULASIES.

Dit het Sy Eksellensie die Goewerneur-generaal behaag om, kragtens die bevoegdheid hom verleen by artikel vier-en-negentig van die Wet op Gevangenis, 1959 (Wet No. 8 van 1959), sy goedkeuring daaraan te heg dat die Gevangenisregulasies, uitgevaardig by Goewermentskennisgewing No. 1352, gedateer 28 Augustus 1959, vanaf datum hiervan as volg gewysig word:—

#### Regulasie 1.

(a) *Afrikaanse teks.*—Voeg tussen die woordbepalings „buiteland” en „herberg” die volgende by „... die Wet”, die Wet op Gevangenis, 1959 (Wet No. 8 van 1959)”.  
(b) *Engelse teks.*—Voeg tussen die woordbepalings „subsistence allowance” en „Treasury” die volgende by „... the Act” means the Prisons Act, 1959 (Act No. 8 of 1959)”.

#### Regulasie 71 (1).

(a) *Afrikaanse teks.*—Skrap die woorde „maak hom skuldig aan ’n oortreding indien hy” in die eerste en tweede reëls en vervang dit deur die woorde „wat die een of ander bepaling van die Wet of van hierdie regulasies oortree of versuim om daaraan te voldoen (behalwe ’n oortreding of versuim wat ingevolge die Wet of hierdie regulasies uitdruklik tot ’n misdryf verklaar is) of wat—”.

#### (b) *Engelse teks.*

#### AMENDMENT OF PRISON REGULATIONS.

His Excellency the Governor-General has been pleased to approve by virtue of the powers in him vested by section ninety-four of the Prisons Act, 1959 (Act No. 8 of 1959), that the Prison Regulations published under Government Notice No. 1352, dated 28th August, 1959, with effect from date hereof be amended as follows:—

#### Regulation 1.

(a) *Afrikaans text.*—Insert the following between the words “buiteland” and “herberg”: “... die Wet”, die Wet op Gevangenis, 1959 (Wet No. 8 van 1959)”.  
(b) *English text.*—Insert the following between the words “subsistence allowance” and “Treasury”: “... the Act” means the Prisons Act, 1959 (Act No. 8 of 1959)”.

#### Regulation 71 (1).

(a) *Afrikaans text.*—Delete the words “maak hom skuldig aan ’n oortreding indien hy” in the first and second lines and substitute therefor the words “wat die een of ander bepaling van die Wet of van hierdie regulasies oortree of versuim om daaraan te voldoen (behalwe ’n oortreding of versuim wat ingevolge die Wet of hierdie regulasies uitdruklik tot ’n misdryf verklaar is) of wat—”.

#### (b) *English text.*

- (i) Delete the word “offences” where it appears in the heading and Section “A” and substitute the word “Contraventions” therefor;
- (ii) delete the words “shall be guilty of an offence if he” in the first and second lines and substitute therefor the words “who contravenes or fails to comply with any provision of the Act or of these regulations (other than a contravention or non-compliance which is expressly declared to be an offence under the Act or these regulations) or who—”.
